

Deed of Appointment/ Retirement of Trustees

This document is provided for use with Aviva Protection UK Limited specimen trust documents and those originally provided by us under our former name AIG Life Limited. The document is to be used to enable Additional Trustees to be appointed and for Trustees to retire (or be removed).

Please read:

The Trust will have appointed the Initial Trustees and this will usually be the Settlor and one other.

This specimen document enables: (a) a Trustee to retire as a Trustee of the Trust; or (b) the Settlor during his or her lifetime (and then the remaining Trustees) to appoint New Trustees in the event of the death or retirement of a Trustee or if there is a need for Additional Trustees to be added.

On the death of a Trustee, the trust property automatically vests in the surviving Trustee(s). Aviva Protection UK Limited must be notified of the death of any Trustee.

All Aviva Protection UK Limited trusts, and those originally provided by us under our former name AIG Life Limited, must always have a minimum of two trustees and it is recommended (but not mandatory) that at least two additional trustees are appointed.

Any person appointed as a Trustee must be 18 years or over.

Appointor(s)	The person or persons with the power to appoint new trustees under the provisions of the Trust or by statute. Depending upon the provisions of the Trust, in most cases this will be the Settlor(s).
New Trustee(s)	The person or persons (if any) who will be appointed as new trustees of the Trust as identified as such in Section C.
Retiring Trustee(s)	The person or persons (if any) who will be stepping down as trustee(s) of the Trust as identified as such in Section C.
Continuing Trustee(s)	The person or persons who will be continuing to act as Trustee(s) of the Trust as identified as such in Section C (and who will also have the power to appoint replacement trustees if there is no Appointor in existence). There must always be a minimum of two trustees.
Trust	The original trust created by the declaration of trust to which this Deed relates and is supplemental to, which is referred to in Section C.

- Where not defined, expressions used in this Deed shall have the same meanings as in the Trust;
- words denoting the singular shall include the plural and vice versa; and
- words denoting any gender shall include all other genders.
